SECTION I: INVITATION TO TENDER

- 1.1 The Kilifi Mariakani Water and Sewerage Co.ltd invites sealed bids from eligible suppliers for the supply of cold water meters and connectors.
- 1.2 Interested eligible candidates may obtain further information from and inspect the tender documents from the procurement office, located at Kilifi town at former K.D.D.P Offices, Off Mombasa-Malindi Road, during normal working hours.
- 1.3 A hard copy of the tender document may be obtained by interested firms upon payment of a non-refundable fee of **Kshs. 1000** payable to our revenue office in cash or banker's cheque payable to Kilifi Mariakani Water and Sewerage Co.ltd. The document can also be viewed and downloaded from the company website www.kilifiwater.co.ke for free **of charge**. Bidders who download the tender document from the website **MUST** forward their particulars immediately for records and any further tender clarifications and addenda to address provided at appendix to instruction to tenderers.
- 1.4 Completed tender documents are to be enclosed in plain sealed envelopes marked with tender name and tender reference number and be deposited in the Tender Box situated outside revenue office at headquarters offices in Kilifi town, former K.d.d.p Offices Off Mombasa-Malindi road or be addressed to;

- 1.5 Prices quoted should be inclusive of all taxes and delivery costs must be in Kenya Shillings and shall remain unchanged for 2yrs period.
- 1.6 Tenders will be opened immediately thereafter in the presence of the Candidates or their representatives who choose to attend at Kilifi Mariakani Water and Sewerage Boardroom.

SECTION II- INSTRUCTIONS TO TENDERERS

2.1 Eligible Tenderers

- 2.1.1 This Invitation for Tenders is open to all tenderers eligible as described in the Invitation to Tender. Successful tenderers shall complete the supply of goods by the intended completion period specified in the Schedule of Requirements Section VI.
- 2.1.2 Kilifi Mariakani Water and Sewerage employees, committee members, board members and their relative (spouse and children) are not eligible to participate in the tender.
- 2.1.3 Tenderers shall provide the qualification information statement that the tenderer (including all members of a joint venture and subcontractors) is not associated, or have been associated in the past, directly or indirectly, with a firm or any of its affiliates which have been engaged by the Kilifi Mariakani Water and Sewerage Co.ltd to provide consulting services for the preparation of the design, specifications, and other documents to be used for the procurement of the goods under this Invitation for tenders.
- 2.1.4 Tenderers shall not be under a declaration of ineligibility for corrupt and fraudulent practices.

2.2 Eligible Goods

- 2.2.1 All goods to be supplied under the contract shall have their origin in eligible source countries.
- 2.2.2 For purposes of this clause, “origin” means the place where the goods are mined, grown, or produced. Goods are produced when, through manufacturing, processing, or substantial and major assembly of components, a commercially-recognized product results that is substantially different in basic characteristics or in purpose or utility from its components
- 2.2.3 The origin of goods is distinct from the nationality of the tenderer.

2.3 Cost of Tendering

- 2.3.1 The Tenderer shall bear all costs associated with the preparation and submission of its tender, and KIMAWASCO will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the tendering process.
- 2.3.2 The price to be charged for the tender document shall not exceed Kshs.1, 000 or free of charge for bidders that download the tender document from Company website or IFMIS procurement portal.
- 2.3.3 All firms found capable of performing the contract satisfactorily in accordance with the set prequalification criteria shall be prequalified.

2.4. The Tender Document

2.4.1 The tender document comprises the documents listed below and addenda issued in accordance with clause 2.6 of these instructions to Tenderers.

- Invitation to Tender
- Instructions to tenderers
- General Conditions of Contract
- Special Conditions of Contract
- Schedule of requirements
- Technical Specifications
- Tender Form and Price Schedules
- Tender Securing Declaration Form
- Contract Form
- Performance Security Form
- Confidential Business Questionnaire
- Declaration of undertaking not to engage in corrupt fraudulent practices
- Manufacturer Authorization

2.4.2 The Tenderer is expected to examine all instructions, forms, terms, and specifications in the tender documents. Failure to furnish all information required by the tender documents or to submit a tender not substantially responsive to the tender documents in every respect will be at the tenderers risk and may result in the rejection of its tender.

2.5 Clarification of Documents

2.5.1 A prospective tenderer requiring any clarification of the tender document may notify KIMAWASCO in writing or by post at the entity's address indicated in the Invitation to Tender. KIMAWASCO will respond in writing to any request for clarification of the tender documents, which it receives not later than seven (7) days prior to the deadline for the submission of tenders, prescribed by the procuring entity. Written copies of the Procuring entities response (including an explanation of the query but without identifying the source of inquiry) will be sent to all prospective tenderers that have received the tender document.

2.5.2 KIMAWASCO shall reply to any clarifications sought by the tenderer within 3 days of receiving the request to enable the tenderer to make timely submission of its tender.

2.6 Amendment of Documents

2.6.1 At any time prior to the deadline for submission of tenders, KIMAWASCO for any reason, whether at its own initiative or in response to a clarification requested by a prospective tenderer, may modify the tender documents by amendment.

2.6.2 All prospective candidates that have received the tender documents will be notified of the amendment in writing or by post and will be binding on them.

2.6.3 In order to allow prospective tenderers reasonable time in which to take the amendment into account in preparing their tenders, KIMAWASCO, at its discretion, may extend the deadline for the submission of tenders.

2.7 **Language of Tender**

2.7.1 The tender prepared by the tenderer, as well as all correspondence and documents relating to the tender exchange by the tenderer and KIMAWASCO, shall be written in English language, provided that any printed literature furnished by the tenderer may be written in another language provided they are accompanied by an accurate English translation of the relevant passages in which case, for purposes of interpretation of the tender, the English translation shall govern.

2.8 **Documents Comprising of Tender**

2.8.1 The tender prepared by the tenderers shall comprise the following components

(a) Tender Form and a Price Schedule completed in accordance with paragraph 2.9, 2.10 and 2.11 below

(b) Documentary evidence established in accordance with paragraph 2.1 that the tenderer is eligible to tender and is qualified to perform the contract if its tender is accepted;

(c) documentary evidence established in accordance with paragraph 2.2 that the goods and ancillary services to be supplied by the tenderer are eligible goods and services and conform to the tender documents; and

(d) tender security furnished in accordance with paragraph 2.14

2.9 **Tender Forms**

2.9.1 The tenderer shall complete the Tender Form and the appropriate Price Schedule furnished in the tender documents, indicating the goods to be supplied, a brief description of the goods, their country of origin, quantity, and prices.

2.10 **Tender Prices**

2.10.1 The tenderer shall indicate on the appropriate Price Schedule the unit prices and total tender price of the goods it proposes to supply under the contract.

2.10.2 Prices indicated on the Price Schedule shall include all costs including taxes, insurances and delivery to the premises of the entity.

2.10.3 Prices quoted by the tenderer shall be fixed during the Tender's performance of the contract and not subject to variation on any account. A tender submitted with an adjustable price quotation will be treated as non-responsive and will be rejected, pursuant to paragraph 2.22

2.10.4 The validity period of the tender shall be 120 days from the date of opening of the tender.

2.11 Tender Currencies

2.11.1 Prices shall be quoted in Kenya Shillings unless otherwise specified in the Appendix to Instructions to Tenderers.

2.12 Tenderers Eligibility and Qualifications

2.12.1 Pursuant to paragraph 2.1 the tenderer shall furnish, as part of its tender, documents establishing the tenderers eligibility to tender and its qualifications to perform the contract if its tender is accepted.

2.12.2 The documentary evidence of the tenderers eligibility to tender shall establish to KIMAWASCO satisfaction that the tenderer, at the time of submission of its tender, is from an eligible source country as defined under paragraph 2.1.

2.12.3 The documentary evidence of the tenderers qualifications to perform the contract if its tender is accepted shall be established to the KIMAWASCO satisfaction;

(a) that, in the case of a tenderer offering to supply goods under the contract which the tenderer did not manufacture or otherwise produce, the tenderer has been duly authorized by the goods' Manufacturer or producer to supply the goods.

(b) that the tenderer has the financial, technical, and production capability necessary to perform the contract;

(c) that, in the case of a tenderer not doing business within Kenya, the tenderer is or will be (if awarded the contract) represented by an Agent in Kenya equipped, and able to carry out the Tenderer's maintenance, repair, and spare parts-stocking obligations prescribed in the Conditions of Contract and/or Technical Specifications.

2.13 Goods Eligibility and Conformity to Tender Documents

2.13.1 Pursuant to paragraph 2.2 of this section, the tenderer shall furnish, as part of its tender documents establishing the eligibility and conformity to the tender documents of all goods which the tenderer proposes to supply under the contract.

2.13.2 The documentary evidence of the eligibility of the goods shall consist of a statement in the Price Schedule of the country of origin of the goods and services offered which shall be confirmed by a certificate of origin issued at the time of shipment.

2.13.3 The documentary evidence of conformity of the goods to the tender documents may be in the form of literature, drawings, and data, and shall consist of:

(a) detailed description of the essential technical and performance characteristic of the goods;

(b) clause-by-clause commentary on the KIMAWASCO Technical Specifications demonstrating substantial responsiveness of the goods and service to those specifications, or a statement of deviations and exceptions to the provisions of the Technical Specifications.

2.13.4 For purposes of the documentary evidence to be furnished pursuant to paragraph 2.13.3(c) above, the tenderer shall note that standards for workmanship, material, and equipment, as well as references to brand names or catalogue numbers designated by the Procurement entity in its Technical Specifications, are intended to be descriptive only and not restrictive. The tenderer may substitute alternative standards, brand names, and/or catalogue numbers in its tender, provided that it demonstrates to the Procurement entity's satisfaction that the substitutions ensure substantial equivalence to those designated in the Technical Specifications.

2.14 Tender Security

2.14.1 The tenderer shall furnish, as part of its tender, a tender security as specified in the Appendix to Invitation to Tenderers.

2.14.2 The Tender securing declaration form shall be duly signed and stamped.

2.14.3 The tender securing form is required to protect KIMAWASCO against the risk of Tenderer's conduct.

2.14.4 Any tender not secured in accordance with paragraph 2.14.1 and 2.14.3 will be rejected by KIMAWASCO as non responsive, pursuant to paragraph 2.22

2.14.5 Unsuccessful Tenderer's tender security will be discharged or returned as promptly as possible as but not later than thirty (30) days after the expiration of the period of tender validity prescribed by KIMAWASCO.

2.14.6 The successful Tenderer's tender security will be discharged upon the tenderer signing the contract, pursuant to paragraph 2.27 and furnishing the performance security, pursuant to paragraph 2.28

2.14.7 The tender security may be forfeited:

(a) if a tenderer withdraws its tender during the period of tender validity specified by KIMAWASCO on the Tender Form; or

(b) in the case of a successful tenderer, if the tenderer fails:

(i) to sign the contract in accordance with paragraph 2.27

or

(ii) to furnish performance security in accordance with paragraph 2.28

2.15 Validity of Tenders

2.15.1 Tenders shall remain valid for **120** days or as specified in the Invitation to tender after the date of tender opening prescribed by KIMAWASCO, pursuant to paragraph 2.18. A tender valid for a shorter period shall be rejected by KIMAWASCO as non-responsive.

2.15.2 In exceptional circumstances, KIMAWASCO may solicit the Tenderer's consent to an extension of the period of validity. The request and the responses thereto shall be

made in writing. The tender security provided under paragraph 2.14 shall also be suitably extended. A tenderer may refuse the request without forfeiting its tender security. A tenderer granting the request will not be required nor permitted to modify its tender.

2.16 Format and Signing of Tender

- 2.16.1 Bidders shall prepare **Two copies (2)** of the tender, clearly marking one “ORIGINAL TENDER” and one “COPY OF TENDER,” as appropriate. In the event of any discrepancy between them, the original shall govern.
- 2.16.2 The original and all copies of the tender shall be typed or written in indelible ink and shall be signed by the tenderer or a person or persons duly authorized to bind the tenderer to the contract. The latter authorization shall be indicated by written power-of-attorney accompanying the tender. All pages of the tender, except for unamended printed literature, shall be initialled by the person or persons signing the tender.
- 2.16.3 The tender shall have no interlineations, erasures, or overwriting except as necessary to correct errors made by the tenderer, in which case such corrections shall be initialled by the person or persons signing the tender.

2.17 Sealing and Marking of Tenders

- 2.17.1 The Tenderer shall seal the original and copy of the tender in separate envelopes, duly marking the envelopes as “ORIGINAL” and “COPY.” The envelopes shall then be sealed in an outer envelope.
- 2.17.2 The inner and outer envelopes shall:
- (a) be addressed to Kilifi Mariakani Water & Sewerage Co.ltd at the address given in the Invitation to Tender:
 - (b) bear, tender number and name in the Invitation for Tenders and the words, “DO NOT OPEN BEFORE,” **Tuesday 30th March,2021 at 1100hrs.**
- 2.17.3 The inner envelopes shall also indicate the name and address of the tenderer to enable the tender to be returned unopened in case it is declared “late”.
- 2.17.4 If the outer envelope is not sealed and marked as required by paragraph 2.17.2, the Procuring entity will assume no responsibility for the tender’s misplacement or premature opening.

2.18 Deadline for Submission of Tenders

- 2.18.1 Tenders must be received by the Procuring entity at the address specified under paragraph 2.17.2 no later than **Tuesday 30th March,2021 at 1100hrs.**
- 2.18.2 KIMAWASCO may, at its discretion, extend this deadline for the submission of tenders by amending the tender documents in accordance with paragraph 2.6, in which case all rights and obligations of the Procuring entity and candidates previously subject to the deadline will therefore be subject to the deadline as extended.

2.19 Modification and Withdrawal of Tenders

- 2.19.1 The tenderer may modify or withdraw its tender after the tender's submission, provided that written notice of the modification, including substitution or withdrawal of the tenders, is received by the Procuring Entity prior to the deadline prescribed for submission of tenders.
- 2.19.2 The Tenderer's modification or withdrawal notice shall be prepared, sealed, marked, and dispatched in accordance with the provisions of paragraph 2.17. A withdrawal notice may also be sent by cable, telex but followed by a signed confirmation copy, post marked not later than the deadline for submission of tenders.
- 2.19.3 No tender may be modified after the deadline for submission of tenders.
- 2.19.4 No tender may be withdrawn in the interval between the deadline for submission of tenders and the expiration of the period of tender validity specified by the tenderer on the Tender Form. Withdrawal of a tender during this interval may result in the Tenderer's forfeiture of its tender security, pursuant to paragraph 2.14.7.
- 2.19.5 KIMAWASCO may at any time terminate procurement proceedings before contract award and shall not be liable to any person for the termination.
- 2.19.6 KIMAWASCO shall give prompt notice of the termination to the tenderers and on request give its reasons for termination within 14 days of receiving the request from any tenderer.

2.20 Opening of Tenders

- 2.20.1 KIMAWASCO will open all tenders in the presence of tenderers' representatives who choose to attend on **Tuesday 30th March, 2021 at 1100hrs** and in the location specified in the Invitation to Tender. The tenderers' representatives who are present shall sign a register evidencing their attendance.
- 2.20.2 The tenderers' names, tender modifications or withdrawals, tender prices, discounts and the presence or absence of requisite tender security and such other details as KIMAWASCO, at its discretion, may consider appropriate, will be announced at the opening.
- 2.20.3 KIMAWASCO will prepare minutes of the tender opening.

2.21 Clarification of Tenders

- 2.21.1 To assist in the examination, evaluation and comparison of tenders KIMAWASCO may, at its discretion, ask the tenderer for a clarification of its tender. The request for clarification and the response shall be in writing, and no change in the prices or substance of the tender shall be sought, offered, or permitted.

2.21.2 Any effort by the tenderer to influence KIMAWASCO in their tender evaluation, tender comparison or contract award decisions may result in the rejection of the tenderers' tender.

2.22 Preliminary Examination

2.22.1 KIMAWASCO will examine the tenders to determine whether they are complete, whether any computational errors have been made, whether required sureties have been furnished, whether the documents have been properly signed, and whether the tenders are generally in order.

2.22.2 Arithmetical errors will be rectified on the following basis. If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantify, the unit price shall prevail, and the total price shall be corrected. If the candidate does not accept the correction of the errors, its tender will be rejected, and its tender security forfeited. If there is a discrepancy between words and figures the amount in words will prevail.

2.22.3 KIMAWASCO may waive any minor informality or non-conformity or irregularity in a tender which does not constitute a material deviation, provided such waiver does not prejudice or affect the relative ranking of any tenderer.

2.22.4 Prior to the detailed evaluation, pursuant to paragraph 2.23 KIMAWASCO will determine the substantial responsiveness of each tender to the tender documents. For purposes of these paragraphs, a substantially responsive tender is one, which conforms to all the terms and conditions of the tender documents without material deviations. KIMAWASCO determination of a tender's responsiveness is to be based on the contents of the tender itself without recourse to extrinsic evidence.

2.22.5 If a tender is not substantially responsive, it will be rejected by KIMAWASCO and may not subsequently be made responsive by the tenderer by correction of the non-conformity.

2.23 Conversion to Single Currency

2.23.1 Where other currencies are used, KIMAWASCO will convert these currencies to Kenya Shillings using the selling exchange rate on the date of tender closing provided by the Central Bank of Kenya.

2.24 Evaluation and Comparison of Tenders

2.24.1 KIMAWASCO will evaluate and compare the tenders which have been determined to be substantially responsive, pursuant to paragraph 2.22

2.24.2 The tender evaluation committee shall evaluate the tender within 30 days of the validity period from the date of opening the tender.

2.24.3 A tenderer who gives false information in the tender document about its qualification or who refuses to enter into a contract after notification of contract award shall be considered for debarment from participating in future public procurement.

2.25 Preference

2.25.1 Preference where allowed in the evaluation of tenders shall not exceed 15%.

2.26 Contacting the Procuring entity

2.26.1 Subject to paragraph 2.21 no tenderer shall contact KIMAWASCO on any matter related to its tender, from the time of the tender opening to the time the contract is awarded.

2.26.2 Any effort by a tenderer to influence KIMAWASCO in its decisions on tender, evaluation, tender comparison, or contract award may result in the rejection of the Tenderer's tender.

2.27 Award of Contract

(a) Post-qualification

2.27.1 In the absence of pre-qualification, KIMAWASCO will determine to its satisfaction whether the tenderer that is selected as having submitted the lowest evaluated responsive tender is qualified to perform the contract satisfactorily.

2.27.2 The determination will take into account the tenderer financial, technical, and production capabilities. It will be based upon an examination of the documentary evidence of the tenderers qualifications submitted by the tenderer, pursuant to paragraph 2.12.3 as well as such other information as KIMAWASCO deems necessary and appropriate.

2.27.3 An affirmative determination will be a prerequisite for award of the contract to the tenderer. A negative determination will result in rejection of the Tenderer's tender, in which event KIMAWASCO will proceed to the next lowest evaluated tender to make a similar determination of that Tenderer's capabilities to perform satisfactorily.

(b) Award Criteria

2.27.4 KIMAWASCO will award the contract to the successful tenderer(s) whose tender has been determined to be substantially responsive and has been determined to be the lowest evaluated tender, provided further that the tenderer is determined to be qualified to perform the contract satisfactorily.

(c) Procuring entity's Right to Vary quantities

2.27.5 KIMAWASCO reserves the right at the time of contract award to increase or decrease the quantity of goods originally specified in the Schedule of requirements without any change in unit price or other terms and conditions.

(d) Procuring entity's Right to accept or Reject any or All Tenders

2.27.6 KIMAWASCO reserves the right to accept or reject any tender, and to annul the tendering process and reject all tenders at any time prior to contract award, without

thereby incurring any liability to the affected tenderer or tenderers or any obligation to inform the affected tenderer or tenderers of the grounds for KIMAWASCO action.

2.28 Notification of Award

- 2.28.1 Prior to the expiration of the period of tender validity, KIMAWASCO will notify the successful tenderer in writing that its tender has been accepted.
- 2.28.2 The notification of award will constitute the formation of the Contract but will have to wait until the contract is finally signed by both parties.
- 2.28.3 Upon the successful Tenderer's furnishing of the performance security pursuant to paragraph 2.28, KIMAWASCO will promptly notify each unsuccessful Tenderer and will discharge its tender security, pursuant to paragraph 2.14

2.29 Signing of Contract

- 2.29.1 At the same time as KIMAWASCO notifies the successful tenderer that its tender has been accepted, KIMAWASCO will send the tenderer the Contract Form provided in the tender documents, incorporating all agreements between the parties.
- 2.29.2 The parties to the contract shall have it signed within 30 days from the date of notification of contract award unless there is an administrative review request.
- 2.29.3 Within thirty (30) days of receipt of the Contract Form, the successful tenderer shall sign and date the contract and return it to KIMAWASCO.

2.30 Performance Security

- 2.30.1 Within Thirty (30) days of the receipt of notification of award from KIMAWASCO, the successful tenderer shall furnish the performance security in accordance with the Conditions of Contract, in the Performance Security Form provided in the tender documents, or in another form acceptable to KIMAWASCO.
- 2.30.2 Failure of the successful tenderer to comply with the requirements of paragraph 2.27 or paragraph 2.28 shall constitute sufficient grounds for the annulment of the award and forfeiture of the tender security, in which event KIMAWASCO may make the award to the next lowest evaluated Candidate or call for new tenders.

2.31 Corrupt or Fraudulent Practices

- 2.31.1 KIMAWASCO requires that tenderers observe the highest standard of ethics during the procurement process and execution of contracts when used in the present regulations; the following terms are defined as follows;
 - (i) "corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution; and
 - (ii) "fraudulent practice" means a misrepresentation of facts in order to influence a Procurement process or the execution of a contract to the detriment of KIMAWASCO, and includes collusive practice among tenderer (prior to or after

tender submission) designed to establish tender prices at artificial non-competitive levels and to deprive KIMAWASCO of the benefits of free and open competition;

2.31.2 KIMAWASCO will reject a proposal for award if it determines that the tenderer recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question.

2.31.3 Further a tenderer who is found to have indulged in corrupt or fraudulent practices risks being debarred from participating in public procurement in Kenya.

APPENDIX TO INSTRUCTIONS TO TENDERERS

The following information regarding the particulars of the tender shall complement supplement or amend the provisions of the instructions to tenderers. Wherever there is a conflict between the provision of the instructions to tenderers and the provisions of the appendix, the provisions of the appendix herein shall prevail over those of the instructions to tenderers.

SECTION III – GENERAL CONDITIONS OF CONTRACT

3.1 Definitions

3.1.1 In this Contract, the following terms shall be interpreted as indicated: -

(a) “The Contract” means the agreement entered into between the Procuring entity and the tenderer, as recorded in the Contract Form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.

(b) “The Contract Price” means the price payable to the tenderer under the Contract for the full and proper performance of its contractual obligations

(c) “The Goods” means all of the equipment, machinery, and/or other materials, which the tenderer is required to supply to the Procuring entity under the Contract.

(d) “The Procuring entity” means the organization purchasing the Goods under this Contract.

(e) “The Tenderer” means the individual or firm supplying the Goods under this Contract.

3.2 Application

3.2.1 These General Conditions shall apply in all Contracts made by the Procuring entity for the procurement installation and commissioning of equipment

3.3 Country of Origin

3.3.1 For purposes of this clause, “Origin” means the place where the Goods were mined, grown or produced.

3.3.2 The origin of Goods and Services is distinct from the nationality of the tenderer.

3.4 Standards

3.4.1 The Goods supplied under this Contract shall conform to the standards mentioned in the Technical Specifications.

3.5 Use of Contract Documents and Information

3.5.1 The tenderer shall not, without the Procuring entity’s prior written consent, disclose the Contract, or any provision therefore, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the Procuring entity in connection therewith, to any person other than a person employed by the tenderer in the performance of the Contract.

3.5.2 The tenderer shall not, without the Procuring entity’s prior written consent, make use of any document or information enumerated in paragraph 3.5.1 above

- 3.5.3 Any document, other than the Contract itself, enumerated in paragraph 3.5.1 shall remain the property of the Procuring entity and shall be returned (all copies) to the Procuring entity on completion of the Tenderer's performance under the Contract if so required by the Procuring entity

3.6 Patent Rights

- 3.6.1 The tenderer shall indemnify the Procuring entity against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the Goods or any part thereof in the Procuring entity's country

3.7 Performance Security

- 3.7.1 Within thirty (30) days of receipt of the notification of Contract award, the successful tenderer shall furnish to the Procuring entity the performance security in the amount and manner specified in Special Conditions of Contract.
- 3.7.2 The proceeds of the performance security shall be payable to the Procuring entity as compensation for any loss resulting from the Tenderer's failure to complete its obligations under the Contract.
- 3.7.3 The performance security shall be denominated in the currency of the Contract, or in a freely convertible currency acceptable to the Procuring entity and shall be in the form of a bank guarantee or an irrevocable letter of credit issued by a reputable bank located in Kenya or abroad, acceptable to the Procuring entity, in the form provided in the tender documents.
- 3.7.4 The performance security will be discharged by the Procuring entity and returned to the Candidate not later than thirty (30) days following the date of completion of the Tenderer's performance obligations as specified in the Special Conditions of Contract, including any warranty obligations, under the Contract.

3.8 Inspection and Tests

- 3.8.1 The Procuring entity or its representative shall have the right to inspect and/or to test the goods to confirm their conformity to the Contract specifications. The Procuring entity shall notify the tenderer in writing in a timely manner, of the identity of any representatives retained for these purposes.
- 3.8.2 The inspections and tests may be conducted in the premises of the tenderer or its subcontractor(s), at point of delivery, and/or at the Goods' final destination. If conducted on the premises of the tenderer or its subcontractor(s), all reasonable facilities and assistance, including access to drawings and production data, shall be furnished to the inspectors at no charge to the Procuring entity.
- 3.8.3 Should any inspected or tested goods fail to conform to the Specifications, the Procuring entity may reject the equipment, and the tenderer shall either replace the rejected equipment or make alterations necessary to make specification requirements free of costs to the Procuring entity.

- 3.8.4 The Procuring entity's right to inspect, test and where necessary, reject the goods after the Goods' arrival shall in no way be limited or waived by reason of the equipment having previously been inspected, tested and passed by the Procuring entity or its representative prior to the equipment delivery.
- 3.8.5 Where the Procuring Entity rejects any component of the Goods delivered, it shall provide a timeline in writing within which the Tenderer shall collect and replace the rejected Goods.
- 3.8.6 Should the Tenderer fail to collect the Goods within the prescribed timelines or any extension thereof granted, the Procuring Entity shall be entitled to charge a storage fee at the prevailing commercial bank rates until all the rejected Goods are collected by the Tenderer.
- 3.8.7 Where the Tenderer despite the extension granted in clause 3.8.5 above fails to collect the rejected Goods, the Procuring Entity shall be entitled to proceed and dispose the rejected Goods in accordance with the procedures outlined in the Public Procurement and Asset Disposal Act, 2015.
- 3.8.8 Nothing in paragraph 3.8 shall in any way release the tenderer from any warranty or other obligations under this Contract.

3.9 **Packing**

- 3.9.1 The tenderer shall provide such packing of the Goods as is required to prevent damage or deterioration during transit to their final destination, as indicated in the Contract.
- 3.9.2 The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the Contract

3.10 **Delivery and Documents**

- 3.10.1 Delivery of the Goods shall be made by the tenderer in accordance with the terms specified by Procuring entity in its Schedule of Requirements and the Special Conditions of Contract

3.11 **Insurance**

- 3.11.1 The Goods supplied under the Contract shall be fully insured against loss or damage incidental to manufacturer or acquisition, transportation, storage, and delivery in the manner specified in the Special conditions of contract.

3.12 Payment

3.12.1 The method and conditions of payment to be made to the tenderer under this Contract shall be specified in Special Conditions of Contract.

3.12.2 Payments shall be made promptly by the Procuring entity as specified in the contract.

3.13 Prices

3.13.1 Prices charged by the tenderer for goods delivered under the Contract shall not, with the exception of any price adjustments authorized in Special Conditions of Contract, vary from the prices by the tenderer in its tender.

3.13.2 Contract price variations shall not be allowed for contracts not exceeding one year (12 months)

3.13.3 Where contract price variation is allowed, the variation shall not exceed 25%, of the original contract price.

3.13.4 Where the variation in contract price results to an increment by more than 25%, such variation shall be tendered for separately.

3.20 Force Majeure

- 3.20.1 The tenderer shall not be liable for forfeiture of its performance security or termination for default if and to the extent that it's delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.

Effect of Force Majeure:

If a Party is prevented from or delayed in performing an obligation hereunder by reason of Force Majeure the affected Party shall:

- (a) be relieved from the consequences of its failure to perform that obligation on a day-to-day basis;
- (b) promptly notify the other parties of the occurrence as soon as reasonably possible by email, telex or cable of the nature of the Force Majeure and the extent to which the Force Majeure suspends the affected party's obligations under this Agreement; and
- (c) use all reasonable endeavours to overcome the consequences of the event and resume performance of its obligations as soon as possible after the Force Majeure condition no longer exists.

Force Majeure Termination:

If an event of Force Majeure continues beyond a period of thirty (30) days, the Parties shall meet in good faith to consult, if no such solution is found, either Party shall be entitled to terminate the obligations of the Parties under the Contract which are affected by such Force Majeure by giving written notice of not less than seven (7) days to the other Party.

Limitation of Liability

To the fullest extent permitted by law, the Procuring Entity, its officers, directors, employees, agents, and subcontractors, shall not be liable for any claims, losses, costs, or damages of whatsoever nature and howsoever arising to the Tenderer, and anyone claiming by, through, or under the Tenderer, resulting from or in any way related to this Contract from any cause or causes, including but not limited to any direct, indirect, general, special, punitive, incidental or consequential damages, loss of income or profit, loss of or damage to property, claims of third parties or other losses of any kind or character.

3.21 Amendments

Any amendment of any term of the Contract entered into by the parties shall only be made by a written agreement between the parties, and such agreement shall be deemed to form an integral part of such Contract.

SECTION IV - SPECIAL CONDITIONS OF CONTRACT

4.1. Special Conditions of Contract shall supplement the General Conditions of Contract. Whenever there is a conflict, between the GCC and the SCC, the provisions of the SCC herein shall prevail over these in the GCC.

SECTION V - TECHNICAL SPECIFICATIONS

5.1 General

- 5.1.1 Tenderers must indicate on the specifications sheets whether the equipment offered comply with each specified requirement.
- 5.1.2 All the dimensions and capacities of the equipment to be supplied shall not be less than those required in these specifications. Deviations from the basic requirements, if any shall be explained in detail in writing with the offer, with supporting data such as calculation sheets, etc. The procuring entity reserves the right to reject the products, if such deviations shall be found critical to the use and operation of the products.
- 5.1.3 The tenderers are requested to present information along with their offers as follows:

5.2.1 PARTICULARS

WATER METERS SPECIFICATION

Introduction

(1) Scope

This specification applies to cold-water meters based on a direct mechanical process involving the action of the velocity of water either through the use of volumetric chambers with mobile pistons or through its effect on the rotation rate of a moving part of a meter.

It applies to water meters with nominal flow rate up to 400 m³/h and with a maximum working pressure of between 10-14 bars for volumetric meters and working pressures of 25 bars for velocity meters

For this purpose, water should be considered 'cold' when its temperature is in the range of 0⁰C to 40⁰C.

(2). Definitions

Flow rate

The flow rate is the volume passing through the meter per unit of time, the volume being expressed in cubic meters or litres and the time in hours, minutes or seconds.

Volume Delivered

The volume delivered is the total volume of water which was passed through the water meter.

Maximum flow Rates, (Q_{max})

The highest flow rate at which the meter can function for a short time without deteriorating and without exceeding the maximum permissible errors and the maximum permissible value for loss of pressure.

Nominal Flow Rate, (Q_n)

Half the maximum flow rate, Q_{max} . It is expressed in cubic meters per hour; the nominal flow rate is used for the purpose of designating the cold-water meter.

Minimal Flow Rate, (Q_{min})

The lowest flow rate at which the meter must not exceed the maximum permissible errors. It is fixed in terms of Q_n .

Flow-Rate Range

The interval between maximum and minimum flow rates (Q_{max} and Q_{min}). This range has lower and upper zones divided by transitional flow rate.

Transitional Flow Rate (Q_t)

The flow rate at which the maximum permissible errors change in value.

Pressure Loss

The difference in absolute pressure between inlet and outlet of a meter at a given flow rate.

GENERAL CHARACTERISTICS**(2).Size**

The meter size is designated by the nominal size of its inlet and outlet threaded connectors. Both the inlet and outlet shall be of the same size and on the same axis.

For each meter size designated the corresponding fixed set of dimensions must correspond to BS 5728/1, ISO 4064/1 and no deviations from this shall be accepted.

(3).Error Limits.

Characteristic curves of accuracy with parallel tables up to the maximum operating capacity are to be provided by the Tenderer. These characteristic curves must be supported by test certificates from the National Standards Institute of the country of manufacture or an equivalent International Standard.

The maximum error permitted in the Lower Zone, from Q_{min} inclusive, up to but excluding Q_t , is $\pm 5\%$. The maximum error permitted in the Upper Zone from Q_t inclusive, upto and including Q_{max} is ± 2 per cent.

(4).Metrological Classes

Water meters shall be considered as divided into three metrological classes according to the value of Q_{min} and Q_t as shown in the following table: -

Characteristic curves of head losses plotted against the rate of flow from the minimum flow rate shall be provided by the Tenderer. The meters shall show a loss of head not exceeding 1 Bar at Qmax in accordance with ISO 4064/1 or BS 5728/1 Part 1

The head losses must be plotted against the whole range of flows.

(6).Accuracy

The meters performance specification shall be to ISO 4064/1 or BS 5728/1 Part 1, Class B or to equivalent internationally recognized Standard. The meters must be able to retain their accuracy when installed in either horizontal, vertical or inclined planes.

(7).Flow Rates

The Tenderer shall state the nominal flow rates of the water meters, supported by copies of the test certificates from the National Standards Institution of the manufacturer's country and a statement of the national or international standards to which these flow rates comply.

ii). Flow Indication

(9).Indicating Device

The indicator shall provide for reliable and unambiguous direct reading of the volume of water measured in cubic metres or in cubic meters and litres.

The indications of volume shall be by any of the two types as follows: -

Type 1 By a row of inline consecutive digits in one or more apertures (drum Counters); or

Type 2 A combination of drum counters for whole units of cubic meters and Pointers on circular scales for fractions of cubic meters.

,Drum counters shall be black for indication of a cubic metre and its multiples shall be red for indication of fractions of a cubic metre. Visible movements of the digits shall be upwards and the actual or apparent height of the digits on the drums shall be not

less than 4 mm. The advance of a digital unit shall be completed while the next lower valued digit is within the last tenth of its travel. The drums showing digits of lowest value shall move continuously in Type 1, and may move continuously in Type 2. Indicators with pointers (Type 2) shall rotate in a clockwise direction. The value of each division on the scales shall be expressed in multiples or sub-multiples of ten. Each scale shall be graduated in cubic meters or accompanied by a multiplying factor (x0.1 x0.01 x10 x100) according to the value of the scale. The symbol m³ shall appear on the dial.

(10). Values Recorded

The indicator shall, as minimum requirement, record the following values: -

Materials and Design

(1). General

The meters to be supplied should be velocity and volumetric type with grooved piston and with mechanical driver counter.

The materials used in the construction shall be designed to withstand raw and treated (potable) water and operate for at least 8 years without normal need for maintenance or repair and without the maximum error exceeding the specified limits.

Tenderers shall specify the optimum pH and the water quality for which the meters have been designed.

They must be constructed throughout of materials which are resistant to internal and external corrosion and if necessary be protected by some suitable surface treatment. All materials of the water meter which are in contact with the water flowing through the water meter shall be non-toxic and non-tainting. Water temperature variations within the working range shall not adversely affect the materials used in the construction of the water meter.

(2). Meter Bodies

For meters of sizes 40mm and above the meters shall have a durable metallic outer case protecting the inside of the meter.

For 15 mm, 20 mm and 25mm, meter sizes the meter bodies shall be made of co-polymer resin that is UV protected.

On all meters the sizes, model and direction of flow shall appear in indelible marking cast in raised characters on the outer case of meter.

(3). External Case Bolts.

Where external case bolts, screw cap bolts, nut and bolts form part of the meter design these shall be arranged for easy removal after a long service. They shall be of the same composition as the meter casing as appropriate or of stainless steel.

(4). Registers

The viewing window shall be of a transparent material which will not shatter, discolor become opaque or distort in normal use. The register (counter) shall be direct straight reading in cubic metres and litres. The counter should be sufficiently sealed to prevent moisture ingress. A hinged lid shall over-lap the viewing window when in the closed position.

Ancillary Requirements.

(1). Strainers

Meters of size 15mm to 40mm shall be provided with effective inlet strainers which shall be of rigid construction, close fitting and designed for easy removal. Meters of size 50mm shall have external strainers quoted separately but included in the total pricing.

The strainer should have an effective straining area of at least three times that of the meter body inlet diameter. Tenderers shall provide details of the materials of construction, aperture size and design of strainers.

(2). Non-return Valves

Meters of size 15mm to 40mm shall be supplied with integral non-return valves. Meters of size 50mm and above shall have external non-return valves quoted separately but included in the total pricing. Tenderers shall provide details of the materials of construction and design of non-return valves.

(3). End Connectors

Meters of size 15mm to 40mm shall be supplied complete with a set of end connectors.

Sealing

Water meters shall be provided with a means of sealing so that after sealing, both before and after the water meter has been properly installed, there shall be no possibility of dismantling or altering the water meter or its adjustment device without visibly damaging the seal. The meters shall be sealed subsequent to manufacture and before delivery to the purchaser.

The preferred method of sealing is by a non-corrosive resistant copper wire inserted through 2.5 mm diameter holes in the halves of the body, and secured by a circular sheet metal seal impressed by a device which provides a unique imprint on the seal.

Tenderers shall provide details of the sealing wire type with proof of corrosive resistant and method proposed.

(1). Marking

Each water meter shall be marked on the casing with the following information

- a) Direction of flow of water on both sides of the meter
- b) Maximum flow rate (m³/hr)
- c) Serial number (engraved)
- d) Manufactures name
- e) Country of Origin
- f) Year of manufacture

The winning tender shall be required to engrave the name of the user company.

(2). Workmanship

The meters shall be guaranteed against defects in materials and workmanship for a minimum period of one year from date of delivery.

Parts to replace those in which a defect may develop within such period shall be supplied without charge, piece for piece, upon the return of such defective parts to the supplier thereof or upon proof of such defects.

Meters should be designed for easy disassembly and re-assembly without the use of special tools or equipment and should be easy to maintain and repair. Meters designed to resist vandalism will be preferred.
